

Abstract

Sorted L-One Penalized Estimation is a relatively new convex optimization method for identifying predictors in large data bases. In this talk we will present the method and report published and new results concerning its theoretical properties and extensions to other statistical problems, including selection of groups of predictors and identifying the structure of gaussian graphical models.
